Mo's Seafood & Chowder wants to help you make some "Clam\$..."

Mo's Original Seafood and Chowder in Newport, Oregon offers our famous fresh clam chowder base to non-profit organizations and schools at a reduced price, which you can sell to make some extra "clams". Fundraising with Mo's is fun, delicious and a lot less labor intensive than most fundraisers.

How To Make Some Extra Clams for Your Organization:

- Determine how much money you want to make and figure out how many people will be able to help you.
- Set a reasonable goal for each person (for example 10 quarts per person).
- Then follow the steps below.

Getting Started:

Have an activity that is fun and upbeat when you announce the fundraiser and challenge everybody to participate.

1. The sale period should be no longer than 10 days. For example, kick off your sale on a Friday and have the first turn in for orders the following Friday with a final turn in on following Monday. This allows two weekends for sales.
2. Call our office (541-265-7512) to place your order and arrange a pick up or delivery date. - DO NOT EMAIL YOUR FINAL ORDER.
3. Deliveries are twice per month on a Wednesday. Please circle your delivery date located on the application. If you sell 75 qts of chowder and within a 3 hr drive of Newport, you qualify for free delivery. If you're further than a 3 hr drive you can qualify for free delivery by selling +200 qts. (Exceptions can be arranged and unforeseen issues happen on both ends so please be flexible.)
4. We need five (5) business days prior to your determined delivery date to complete your order.
5. If you choose to pick up your order, just let us know what time and day work best. We are open 7am-1pm Monday-Friday.

Our clam chowder base is a quick and easy meal for every day dinner ideas. It is also very popular around the holidays and is perfect for parties at home like the Super Bowl or the Civil War Game. Mo's clam chowder base is a fresh product that must be kept refrigerated. It has a 4 week shelf life in the refrigerator or may be frozen for up to 3 months. One quart makes five 10oz bowls.

- When you know your start and end date please sign and email the application and contract back to Mo's Annex in Newport. Email: gabe@moschowder.com & carter@moschowder.com. Once your application and contract are received you will get a confirmation email. If you do not get a confirmation within 48 hours please call our office at 541-265-7512.

Pre-Sell:

- Collect the money from customers as they order.
- Challenge everyone to reach the goal.
- Use incentives (especially with kids) to reach your goal.

Chowder Day:

- Order your quarts of chowder base at 541-265-7512 Monday –Friday 10 am to 3 pm.
- Please allow **five (5) complete business days** prior to your selected delivery day for production and packaging of your order.
- Options to receive your order:
 - Pick up: Arrange time and day for pick up at Original Mo's Restaurant in Newport.
 - Delivery: Deliveries are twice per month on a Wednesday. Please circle your delivery date located on the application. If you sell 75 qts of chowder and within a 3 hr drive of Newport, you qualify for free delivery. If your further than a 3 hr drive you can qualify for free delivery by selling +200 qts. (Exceptions can be arranged and unforeseen issues happen on both ends so please be flexible.)
 - All deliveries will go out on your chosen delivery date; delivery days are on Wednesday.
- Circle a Delivery Date: All deliveries will go out on your chosen delivery date; delivery days are on **Wednesdays: 2025 Schedule:** Sep 24, Oct 8, Oct 22, Nov 5, Nov 19, Dec 3, Dec 17. **2026 Schedule:** Jan 7, Jan 21, Feb 4, Feb 18, Mar 4, Mar 18, Apr 1, Apr 15, Apr 29, May 13, May 27 (Break for Summer, Fall 2026 delivery dates are released in August). Other dates and arrangements can be made for special circumstances.
- Please be prepared with your own coolers or refrigeration of some kind to keep your order cold until the chowder can be delivered to your customers.

Make sure your cooler size fits your order.

(This is only a an approximation guide)

- Mo's Clam Chowder base comes in a 1qt (32 oz) sized clear plastic food grade barrier bags with a label and cooking directions. This is a fresh product and must be refrigerated and should be delivered to buyers the day of delivery or no later than the following day. Mo's Clam Chowder has a 4 week shelf life in the refrigerator and can be frozen for up to 3 months.

What Does It Cost and How Much Can You Make?

Selling price \$15.00 per quart. You make \$5.00 for every quart you sell.

For example: If you sell 200 quarts you'll make \$1,000.00 profit!

Incentives From Mo's...

For every 25 quarts sold receive \$10.00 in Mo's Gift Certificates.

Mo's gift certificates are good for purchase of food, beverage or gift shop items. You can redeem them at any Mo's Restaurant on the Oregon Coast.

Payment is due upon receipt or call in our office prior to delivery with a credit card.
